December loss of \$13,000 (something), \$2.2 k profit "December reversed a losing trend for 2015 by adding a profit of \$2.2k for the month primarily the result of stronger 7th tradition income and increased literature sales. 2015 overall losses produced a significant shortfall of (\$9.3k). While January has been jump-started by a highly successful and well-attended New Years Eve Party which netted \$4.2k, Intergroup reps are still asked to continue make their groups aware of our shortfall for the previous year.

Discussion Topics: Counterfeit bills at meetings

- At several different times, central office has come across counterfeit bills- 3 \$20's and 1 \$50 bill. What to do if you find one?
- Special events NYE got one, was given to someone to buy ice and couldn't, also someone stole some money from basket
- Are people putting \$20 in basket and taking \$19 back?
- Some don't even know they had it
- Meetings can use counterfeit pens
- It's a federal crime, call the police on them
- Can't figure out who put the bill in the basket if it's a huge meeting
- At big meetings, Teresa's home group in LA, people would stand in isle to pass basket and if someone needed change, they raised their hand and someone else would get it instead of the person taking the change from basket themselves
- At candlelight meetings, would be awkward to hold the bill up to check if it's fake
- There's no real solution, can't have a basket monitor at every meeting, but to be aware of the issue and spread this to our groups
- The person who does this is not working steps, if we see person putting in a \$50 bill we can talk to him/her and/or keep an eye out for others doing this
- People are sick, depends on how each group wants to handle it
- People making amends later for stealing money from basket, we can pray for them and hope they make amends
- Stay by the rule, no exceptions
- Easy way to tell on \$20 bill, take fingernail down jacket, can feel it's slightly raised or embossed on real bill, jacket feels smooth on fake bill
