Central Office Report

Steve recited written report: October yielded a virtual break-even result by recording a minor loss of (\$.2) for the month and \$10.2k for the year. This compares favorably to a minor loss of (\$.5k) last year for the month and YTD loss of (\$7.5k). Two key factors which account for the year to year change: 7th tradition is up +\$15.2k, payroll is down (\$6.9k) with SE income off (3.2k).

Our month-end cash position ended at the same \$95.5k, which includes \$71.4k in reserves and \$24.1k in operating accounts. Total inventory value ended grew slightly to \$20.7k.

"Due to increased need from member groups for this benefit and effective immediately, the Service Board has approved the extension of our General Liability Policy to include coverage of meetings in our Intergroup area that need proof of insurance for their respective meeting spaces by the landlord. At this time, this offer will not include fellowships or Alano Clubs who may have broader insurance requirements than this policy contemplates.

Coverage is for a maximum liability of \$2,000,000.

Meetings or Groups wishing to apply for certification of coverage will be changed \$40 per year for the first weekly meeting at a specific location and \$25 per year any additional meetings."

- It bothers me—especially during a candlelight meeting.
- Nowadays, phone are more than just phones.
- It bugs me because I feel it's disrespectful.
- How is the newcomer going to feel like the most important person in the room if everyone is on their phone. We are here for a primary purpose for one hour.
 Facebook during a meeting is disrespectful.
- We are not the "thought police". I try to be tolerant. Our groups might lose members if we are too rigid.
- I remember a guy who would read a book during the meeting. He was courtordered. We have members who knit or read. I don't think the phone is distracting.

<u>Discussion Topic</u>: "A groups has difficulty paying its rent through 7th tradition collections but receives substantial amounts through H&I cans. It is considering combining both sources of contribution and disbursing a pre-set percentage to H&I. Can these funds be combined? Can it be combined while H&I is running a large surplus? Can money received from the Pink Can be reassigned by a group conscience to do so, or are monies donated for a specific purpose committed to that purpose?

Discussion

- With info about H&I surplus each group should let their membership know within their own group. Make announcement at group level.
- Primary purpose is to hold a meeting space. Rent paid first. If not, send basket around again. When I put money in a certain can, I expect it to go to where that can says it's to go.
- In-Between Fellowship has H&I info posted. Money belongs to the Pink Can.
- BFAA had group conscience about the H&I can. Door needs to be open first. We itemize
 everything we do when 7th Tradition is passed so everyone knows where the 7th Tradition
 goes. Pink can is not circulated.
- There has been an increase to the 7th Tradition with out the Pink Can circulated.
- H&I is a huge in this area esp. Alameda County. In the rest of the country they don't have H&I.
- H&I is not part of the groups. We are not mandated to contribute to H&I.
